<u>RECORD OF PROCEEDINGS</u> Minutes for the Village of Beverly Special Council Meeting Tuesday, June 22, 2021

• A special meeting of the Village of Beverly Council was held Tuesday, June 22, 2021 at 7:00 PM with Mayor Jim Ullman presiding. PURPOSE:

- Arnold moved to present Resolution #21-06 for the first reading by title only. Baker seconded the motion. Roll call (6-0); motion passed.

- Hopkins moved to make the following wage adjustments effective with pay period beginning June 28, 2021: Aaron Perine, additional \$1.00 per hour; Bradley Oliver, additional \$1.00 per hour; and Kyle Lang, additional \$.50 per hour. Baker seconded the motion. Roll call (6-0); motion passed.
